Terms and Conditions

1. Autism Association of Western Australia (ABN 54 354 917 843) of 215 Stubbs Terrace, Shenton Park WA 6008 ("we" or "us") are responsible for conducting the 'Win a signed Gilly bat!' ("the Competition").
2. By entering into this Competition you agree to these Terms and Conditions.

Competition Period

4. The competition commences at [09:00 AWST on 14/11/2023 and closes at 17:00 AWST on 31/01/2024] ("Competition Period").

Conditions of Entry

5. Entry is open to West Australian residents aged 4 years or over at the date of entry and who are accessing services with the Autism Association of WA. Any persons under the age of 18 must have parent or guardian approval to enter and to provide personal information.
6. Employees (and their immediate family) of the Autism Association of WA are ineligible to enter.
7. To enter the Competition, [game of chance] entrants must have:
 - linked up with the Autism in Cricket program either by emailing the Autism in Cricket email address, registering via our website or RSVPing to attend the WACA Come and Try Session;
 - registered to play cricket at a community club for the 2023/24 season;
 - completed a player profile (from the Autism in Cricket website) and emailed the Autism in Cricket email address to confirm they have registered to play cricket and attached their player profile; during the Competition Period ("Entry").
 - any persons who has already registered their details with the Autism in Cricket team prior to the competition start date will automatically be in the draw.
8. Limited to one Entry per person.
9. We reserve the right to check the validity of all entries and to disqualify any entries if we reasonably believe that your entry does not comply with these Terms and Conditions.
10. Entries that are considered, in our absolute discretion, to be unlawful, defamatory, abusive, obscene, sexist, racist or otherwise inappropriate will be deemed invalid and rejected. We reserve the right to provide law enforcement bodies with the objectionable Entry and the entrant's personal information.

How to Win

11. The Competition is a game of chance, where everyone has the same chance of winning. The winner will be chosen at random.
12. A person may only win a maximum of one Prize.

13. Winners (Winner and Runner Up Winner) will be emailed and contacted by telephone by a member of the Autism in Cricket team on [05/02/2024].
14. Prizes must be claimed from 215 Stubbs Terrace, Shenton Park, WA 6008.
15. The winner must claim their prize within 7 business days of being notified, after which they will forfeit the prize. The Runner Up will become the winner ("Replacement Winner"). If the Replacement Winner does not claim their prize within 7 business days of our notification, that Replacement Winner will forfeit the Prize.
16. Our decision on all aspects of this Competition is final and no discussion will be entered into.

The Prize

17. A total of 3 Prizes (First Prize, Second Prize and Third Prize) are available to be won. The Prize does not include any other expenses, such as costs to travel.
18. First Prize is 1 x cricket bat signed by Adam Gilchrist.
19. Second Prize is 1 x *Adam Gilchrist's Champions of Cricket* book.
20. Third Prize is 1 x *Adam Gilchrist's Champions of Cricket* book.
21. Given the uniqueness of each prize, there is no monetary value attributed to them. The Prize does not include any other expenses, such as costs to travel.
22. The Prize is awarded "as is" and is not transferable or exchangeable for cash. Any unused portion of the Prize will be forfeited. If any element of the Prize becomes unavailable, we reserve the right to substitute the Prize with another prize of equal or similar value.
23. We may require that a winner provide acceptable identification before awarding a Prize.
24. We are not responsible for any failure or inability on the part of any winner to redeem a Prize.

Privacy

25. By entering in this competition, you agree to us collecting, using and/or disclosing your personal information for the purposes of the competition. 26. You agree to us publishing your name and entry (and, if requested, a photograph of you), free of charge, in any media (including social media) for the purpose of promoting this Competition and/or our products.

Right to Amend

27. We reserve the right to suspend, cancel or modify the Competition if necessary, due to circumstances beyond our reasonable control. We will take reasonable steps to notify you of any such change.

Release

28. Nothing in these Terms and Conditions limits, excludes or modifies the consumer guarantees provided under the Competition and Consumer Act (2010) or any other statutory rights that you have that cannot lawfully be excluded.

To the extent permitted by law, we exclude and you irrevocably release us and our employees and contractors from, all liability for any loss or injury suffered by you in connection with your participation in the Competition or any of your activities in connection with any Prize that you win as a result of your participation in the Competition, except where such loss or injury is caused by our negligence.
30. We are not responsible for any incorrect or inaccurate information, either caused by promotional website users or by any of the equipment or programming associated with or use in this competition, or by any technical error that may occur in the course of the administration of this competition.
